HOA Policy Regarding Signs

Now therefore in accordance with the *Declaration of Covenants* Article XIII, Section 1, the HOA declares the following to be its **Official Event Signs Policy**:

WHO May Place Signs:

- Any recognized group or organization operating within the properties may place signs to advertise an event.

HOW MANY AND WHERE:

- Three (3) signs of the approved size and design may be displayed at approved locations for seven (7) **consecutive** days including the day of the event.
- One (1) additional sign of the approved size and design may be placed at the entrance to Heron's Glen Clubhouse parking lot **on** the day of the event (please see accompanying map for exact approved locations).
- **ALL** signs will be removed at the conclusion of the event.

TYPE AND SIZE

- Approved size and design for signs shall be: 18"x24" in size with a **white** background with either aqua-green or black lettering.
- Signs shall be displayed on a "Banjo" style metal frame.
- Signs shall be **Professionally** made to comply with the approved size and appearance.

PROCEDURE FOR OBTAINING APPROVAL

- **ALL** groups or organizations **must** apply **BEFORE** placing any signs.
- Only **one** group during a seven-day period may display the maximum number of event signs.
- Applications will be approved on a first-come, first-served basis.
- **ONLY** approved size and design will be used.
- The following groups may apply at **least one** month prior to their event: The Artist Group, The Chorus Group, The 3-D Art Group, The Craft Show.
- All other groups must apply at **least two** months prior to their event.
- An application will be obtained at the HOA office and returned completed to the HOA office.

NO SIGN SHALL BE PLACED WITHOUT HOA APPROVAL

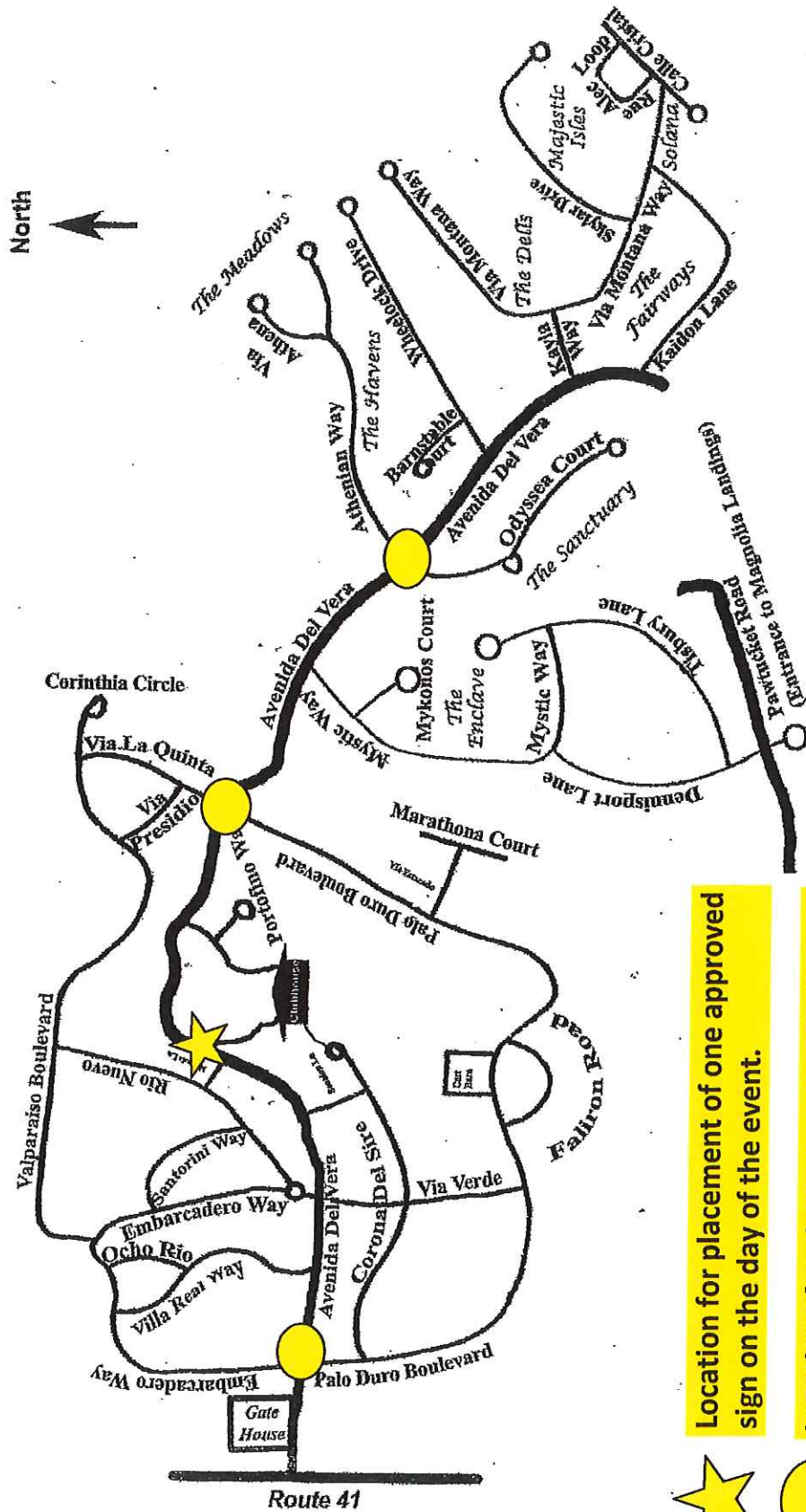
Obtain **signs** from ARTYPE located in Fort Myers on Work Street (off Hanson Street) at about \$15-\$18
