FIRST AMENDMENT TO THE BYLAWS OF SOLANA AT HERONS GLEN HOMEOWNERS ASSOCIATION, INC.

WHEREAS, pursuant to Article XIII, Section 1. of the Bylaws of Solana at Herons Glen HOA, Inc., the Bylaws may be amended by a majority vote of directors at a regular or special meeting, and WHEREAS, at a regular meeting of the Board of Directors on May 17, 2007, the Directors unanimously decided to amend the provisions of the Bylaws pertaining to the number of directors and the term to be served.

NOW THEREFORE, the Bylaws are amended as follows:

- The original <u>Article IV BOARD OF DIRECTORS</u>, <u>Section 1. Number</u> is deleted in its entirety and the following substituted in its place.
 - "Section 1. Number. The affairs of this Association shall be managed by a Board of Directors which shall consist of an odd number of directors with a minimum of three (3) and a maximum of five (5)."
- 2. The original <u>Article IV Section 2</u>. <u>Term of Office</u> is deleted in its entirety and the following substituted in its place.

"Effective with the January 2008 annual meeting, directors shall be elected to three-year (3-year) staggered terms. There shall be no limit on the number of consecutive terms a director may serve. At the director's organizational meeting following the January 2008 election, all directors shall draw straws to determine which directors will serve initial terms of one (1), two (2) or three (3) year terms. Thereafter, annual elections shall be held to replace directors with expiring terms and all newly elected directors shall serve a three (3)-year term."

In all other respects the Bylaws shall remain unmodified and unchanged.
