Meeting of March 20, 2025

The HOA Activities Committee met on Thursday March 20, 2025. Completed Events

- The annual Shredding Event was held on Monday, March 3, 2025. The event resulted in the shredding of 3980 pounds of documents, demonstrating the community's commitment to security and sustainability. The \$350 cost for the manned shredding machine was offset by donations from residents utilizing the service.

- The Ice Cream Social is on Sunday, April 6th, 2025, from 4-6 pm in the Ballroom. Entertainment by the Island Coast High School Jazz Band. Donations will be accepted for the school band. Volunteers will rotate scooping due to high volume. Toppings were chosen to stay within budget. Table decorations will be borrowed from the HGRD Resident Events Committee.
